The funeral took place at the Presbyterian church on Friday afternoon. A long line of carriages and buggies followed her remains to Lake Cemetery. Died at her home in Lamar, at 1 o'clock Thursday morning, December 6 th of heart disease and general disability, Chattie A., daughter of Joseph C. and Nancy Parry, age 22 years, 11 months, and 6 days.
PITTENGER, MARY	Lamar Democrat, January 12, 1888 We learned from E. E. Cresswell and Frank Wise who came to Lamar after the coffin on Friday last, of the death of little Mary, the daughter of Mr. and Mrs. Al Pittenger. Her disease was diphtheria.
PORTER, ELLA	Lamar Democrat, January 12, 1888 Died, southwest of Esrom early Wednesday morning, January 4 th , 1888, after intense suffering for two weeks, little Ella, infant daughter of K and R. Porter, aged 1 year and 1 month.
PUGH, EDWARD	Lamar Democrat, August 9, 1888 Died on August 3, Edward Pugh, son of Mr. and Mrs. D. Pugh, living on the Stephens farm, southeast of Lamar. The little fellow was only seven months old. His death was caused by cholera.

REX, MARY	 Lamar Democrat, September 27, 1888 J. W. Rex telegraphed his brothers on Saturday that their sister Mary, living in Ohio was very ill and not expected to live. Robert Rex left on Sunday and G. W. Rex of Jasper City left on Wed. Later news—She died on Thursday, September 27th, 1888. All three brothers were present.
RICHARDSON, JOHN M. MRS.	Lamar Democrat, August 30, 1888 Mrs. John M. Richardson, wife of Col. Richardson, well known in this county, died at Abilene, Kansas on Wednesday, August 22 nd .
RYAN, ALLIE	Lamar Democrat, August 2, 1888 Died on Wednesday, July 25 th , 1888, Miss Allie Ryan, aged 20 years. She was sick only a few days. Mr. and Mrs. Ryan were in Colorado at the time of their daughter's death.
SHEPHERD, SARA M.	Lamar Democrat, August 2, 1888 Died on Saturday, July 28 th , 1888, at the Commercial House in Lamar, Missouri, Sara M. Shepherd, infant daughter of Mr. and Mrs. W. Shepherd, aged 10 months and 20 days. The little child was buried in Lamar cemetery on Sunday.
SMITH, INFANT	Lamar Democrat, October 25, 1888 A three year old child of Wm. Smith, at the Pacific Coal works near the town of Minden Mines, about 20 miles west of here fell into a cistern Monday evening and was drowned.
SNYDER, ASA	Lamar Democrat, May 3, 1888 Asa Snyder, son of N. K. Snyder, aged 18 years while visiting relatives in Kahka, Clark county, Missouri, met his death by accident on the 27 th of April by falling from a scaffold. He was engaged in painting the Baptist Church and the scaffold he was standing on gave way. Asa was well known in the county as he and his parents resided here for many years. They are now living in Eldorado Springs, while a large number of relatives still live in this county.
SPEECE, B. F.	Lamar Democrat, January 26, 1888 Died in Lamar on Tuesday morning, January 24 th , 1888 B. F. Speece aged 51 years. He was a member of McCook Post GAR.
STEELMAN, DAVID	Lamar Missouri, May 24, 1888 On last Wednesday evening David Steelman, Mr. Manning and Dr. Speece went to the creek with the purpose of setting a trammel net. The creek was high and the boat upset and Steelman went down within a few feet of the bank. He was in about 10 feet of water and only came up once and said "Oh, Oh " and was never seen again. Manning was saved by the efforts of Dr. Speece. Manning was purple when pulled

	from the water and said the first thing he remembered was Dr. Speece rubbing him. The body was searched for that night but it took some hours work on Thursday to find it where he had sank. There were 200 people present and most of those friends with David Steelman, the genial station agent for the Missouri Pacific Railroad at Beloit. Young Steelman was about 22 years old and his family well known all over the county.

He leaves a wife and two sons, one of his daughters, Mrs. L. Capron, is now living in Lamar.
TEETER, HARRY	Lamar Democrat, November 22, 1888 The following is in memory of Harry Teeter, son of Mr. and Mrs. G. S. Teeter, who died Thursday, November 15 th , 1888. A poem followed this.
THORNTON, SADIE	Lamar Democrat, July 26, 1888 Died on July 18 th , Sadie Thornton, daughter of John Thornton, aged 10 months. Mr. Thornton lives in Union township.
THURMAN, MR.	Lamar Democrat, January, 19, 1887 Just as we go to press last, we learned of the death of Mr. Thurman, father of our fellow citizen, B. G. Thurman, who was present during the last days of his illness.
