She had been partially deranged for some time and her husband had her under strict surveillance for some time. On Tuesday afternoon about 4 o'clock he came up town and during his absence her clothes caught fire and she ran out of the house to the sidewalk and fell down. The neighbors came to her rescue, but it was too late. She had breathed the flames to an extent that at 6 o'clock she died. She would have recovered from the skin burns, no worse than they were.
