

Charles E. "Chuck" Vaughan, age 79, of Lamar, passed away at 11:23 p.m. Sunday, November 19, 2006, at Barton County Memorial Hospital.

Chuck was born November 12, 1927 in Kansas City, Missouri, to Bus and Sue (Jefferson) Vaughan. The family moved to Lamar in 1944, owning and operating a restaurant on the north side of the Lamar square. Immediately after graduating from Lamar High School in 1945. Chuck was inducted into the U.S. Navy. On May 25, 1947, he married Patricia Marie Kazee and they made their home in Lamar, where Chuck worked for Lawn Boy. They moved to Waukegan, Illinois with Lawn Boy in 1962. In1972 they purchased Kelly's Package Store in Dallas, Texas. They moved back to Lamar in 1974, owning and operating Three Brothers Automotive in Lamar, Joplin, Neosho, Pierce City, Mt. Vernon, and Parsons, Kansas until retiring in 1993. Chuck was a member of Lamar Masonic Lodge #292, Abou Ben Adhem Shrine, Lamar Elks Lodge #2800, a former member of Lamar Rotary Club and a charter member and past president of Lamar Country Club. He served for many years on the Barton County Memorial Hospital Board serving as chairman for several terms. He attended Lamar United Methodist Church.

Survivors include his wife of 59 years, Pat Vaughan, of the home; a son and daughter-in-law, Mike and Fran Vaughan, Lamar; a brother and sister-in-law, Everette Jr. & Jerri Vaughan, Des Moines, Iowa; two grandchildren and their spouses, Brandon & April Vaughan, Lamar, and Courtney & Donnie Dec, Kansas City. He was preceded in death by his parents and a sister, Vivian Jean Vaughan.
